### **37<sup>th</sup> STATE JUNIOR URBAN CHAMPIONSHIPS AT ECHUCA** **SATURDAY 20<sup>th</sup> & SUNDAY 21<sup>st</sup> FEBRUARY, 2010**

This special notice is circulated to all brigades who will be attending the Association's 2010 Junior State Urban Championship, or who have members appointed to be Officials.

Brigade Secretaries are asked to:

- 1) Ensure completion and return of the two forms enclosed eg.  
Registration of Junior Members and Barbeque Form  
by **Friday 5<sup>th</sup> February 2010.**
- 2) To bring this notice to the attention of:-
  - Brigade members appointed as Officials
  - Brigade coach
  - Brigade Officer or Member in charge of the Junior Brigade.

#### **APPOINTMENT OF JUDGES AND OFFICIALS:**

List of Judges and Officials appointed for the Junior Championships is attached.

To effectively cater for several areas of function, it was necessary to vary the preferred choice of some officials offering their service. To those members, the Association trusts that their appointed position will be accepted in good faith. Should any Brigade member named as a Judge or Official not be able to attend or be available on both days, could I be advised as soon as possible so that alternative arrangements can be made to ensure full coverage in all areas.

Judges and Officials are requested to report to the Chairman of Judges' office at the Competition Track between 1600 and 1700 hours on the Friday afternoon. Alternatively, Officials can report to the Chairman of Judges' office on the Saturday morning following the Official Opening.

Officials are requested to be in attendance at the plug line at the conclusion of the event prior to their appointed event, so that they can be issued with a tabbard, have their name ticked off and any information may be communicated to them.

At all times when officiating, approved CFA dress uniform or summer uniform to be worn. The service style NATO jumper is approved attire in lieu of the blue dress uniform coat. All officials will wear an appropriate tabbard while officiating.

## **COMPETING BRIGADES**

Seventy Nine (79) teams have entered to participate in all events including Esperance (Western Australia).

## **DISCIPLINE AND BEHAVIOUR**

The Officer in Charge of each Junior Brigade is responsible for the discipline and behaviour of the attending members at all times.

The Association asks for the co-operation of the Brigade Officers and Officer in Charge to ensure that recognised standards of discipline and behaviour are observed.

Initiation practices or behaviour are not acceptable and will not be tolerated at the risk of disqualification from the Championship or future Championships.

Senior members of Brigades are asked to observe the established standard that consumption of alcohol on or in the vicinity of the competition tracks, Opening Parade or at Presentation Ceremony is not permitted. Co-operation of senior members would be appreciated at the State Junior Championships.

## **PROGRAM OF EVENTS**

The order of events are attached and to be noted, that ROLL CALL for Brigades on Saturday is at 0815 hours for commencement of the Opening Parade at 0830 hours, and on Sunday at 0815 hours with events on both tracks to commence at 0830 hours. Events will continue through the lunch period on each day to assist with finishing at a reasonable time. Officials and competitors to take lunch break as their rostered events allow.

## **OPENING PARADE**

For the Opening Parade teams will be lined up in 2 sections in a random order, as per the attached list.

Junior Brigades will assemble in the order of brigades as listed in Crofton Street, which is located to the south of the Track in the vicinity of the road leading in to the track.

On Occupational Health grounds, the Association has approved competitors wearing hats during the Opening Parade subject to the following conditions:-

- (a) hats must incorporate brims to protect the entire head,
- (b) the same style and colour of hat being worn by all members of the respective team,
- (c) baseball caps not being approved.

## **SAFETY CO-ORDINATOR**

In continuing the emphasis on Occupational Health and Safety at competitions and Championships, Safety Co-ordinator s will be appointed to oversee all safety related aspects both on the competition track and within the grounds. If brigades have any safety concerns, they should be reported to the Association office.

## **INFORMATION FOR BRIGADE COACHES**

The conduct of all events shall be in accord with the Association's Urban Competition Conditions and Rules as prescribed in the 2008 Rule Book.

Coaches should take care that rules governing Juniors competing in the two age groups are fully observed as any infringement shall be liable for Brigade disqualification.

### **AGE SECTIONS**

Coaches should ensure that:

- 1) Junior competitors to be enrolled with their respective Junior or Senior Brigade and registered with the Country Fire Authority prior to competing. Junior and Senior Brigades to be affiliated with the Association.
- 2) Under 14 Years: Junior competitors competing in the Under Fourteen (14) years section events shall be aged eleven (11) years; and to be under fourteen (14) years on the 1<sup>st</sup> October 2009.
- 3) Under 17 Years: Junior competitors competing in the Under Seventeen (17) years events shall be under the age of 17 years on the 1<sup>st</sup> October 2009.

N.B. These conditions apply notwithstanding all the sixteen year old Junior competitors being enrolled as members of their respective Senior Brigade, and whether or not they have competed in senior competition events.

**NOTE:** To comply with conditions above, each Brigade to complete an attached **Registration Form** for each Junior team entered. Completed Registration Forms to be returned to Association Office prior to **Friday 5<sup>th</sup> February 2010**. To note carefully conditions printed on the reverse side of Registration Form.

### **SPECIAL REMINDER**

Brigade hydrants to be used in the wet events to be weighed, checked and sealed on Friday evening between 1500 hours and 1700 hours, or on Saturday and Sunday mornings between 0730 hours and 0800 hours. When checking hydrant, couplings attached to Association provided hoses may be checked for coupling to hydrant. The timing of the water will take place prior to 0815 hours on each day of the Championships. The times to be announced following each test.

### **SCRATCHING FROM EVENTS**

With procedure of accepting entry of Brigades in all events, the co-operation of coaches is sought, and if the brigade is not to compete in an event or events, a scratching form should be completed at the Association Office in ample time prior to the event.

Brigade competitors when not in attendance when called by the Marshalling Officer to participate in an event, will be disqualified.

### **PROTESTS**

Official Protest Forms are available from the Association Office and only these forms will be recognised. To assist with conduct of event being conducted, Brigades intending to lodge a protest must also inform the officiating Track Master of their intent **WITHIN FIVE MINUTES** of the completion of their run.

The decision of the Protest Committee shall be final, and if the protest is deemed by the Committee to be frivolous, the Brigade shall forfeit the deposit.

Where a Protest is upheld and the brigade was competing in pairs, unless exceptional circumstances exist, the announced winner of the heat will not run in the next round or final (unless included in the fastest losing teams).

## **GENERAL INFORMATION**

**ADMISSION TO GROUND:** Public admission will be free for all attending. Programs will be available for purchase at entry areas and within the ground.

**DRAW OF EVENTS:** The draw for each event will be available from the VFBV Web page two weeks prior to Championship.

**PARKING:** Adequate parking is available in the vicinity of the track. Parking is available within the Reserve with entry from Crofton Street. Parking for buses will be accommodated within the Reserve off Crofton Street (signs will direct buses to parking areas). On street parking in adjacent roads is available, but do observe local road parking signs.

**MEALS:** The brigade will provide breakfast at the track on each day. Food and light refreshments, take away foods, soft drinks and ice cream will be available on both days.

**BRIGADE AWNINGS:** Brigade awnings will be permitted outside the perimeter of the track in areas as directed by the Championships Committee.

## **BARBEQUE LUNCH**

The Country Fire Authority has funded the Local Committee to provide a Barbeque Luncheon on Sunday which will be arranged in the vicinity of the marshall track.

Free luncheon tickets will be available for all attending brigade junior competitors, appointed officials and a maximum of four persons to cover - coach, drivers or chaperones. For other adults and children, luncheon will be available at \$13.00 per meal. Payment for additional meals and issue of tickets will be arranged on the Saturday afternoon at the Local Committee's Office.

To ensure catering numbers are known, the attached Barbeque return form is to be completed and returned to the Association Office by **Friday 5<sup>th</sup> February 2010.**

## **COMPETITION DRESS (TROUSERS)**

Coaches and team managers are requested to closely check the correctness of trousers worn by their Junior members and to avoid putting Officials in the position of disqualifying or speaking to a Junior member for failing to observe wearing:-

"Ankle length trousers, (centre of ankle bone) with trouser legs neither tied, rolled nor held in socks; or featuring leg side zips or stirrups, or being skin tight in fitting". (Rule 19b).

Please avoid any embarrassment and sadly upsetting junior competitors.

## **PRESENTATION OF TROPHIES**

Individual and station trophies will be presented on the track on which the event is conducted at the completion of the event. Could coaches please make sure that placed competitors are ready for the presentation ceremony immediately the event concludes.

Aggregate Trophies will be presented on the main track following counting of aggregate points at conclusion of the final event. Senior Members and Junior Members to be presented with these special trophies are asked to be in full dress uniform, competition dress or in brigade official tracksuits.

The presentation Ceremony will conclude with the reading of the Epilogue and Playing of the National Anthem.
