### **127<sup>th</sup> STATE URBAN CHAMPIONSHIPS AT MILDURA SATURDAY 6<sup>th</sup>, SUNDAY 7<sup>th</sup> & MONDAY 8<sup>th</sup> MARCH, 2010**

This special notice is circulated to all Brigades who will be attending the 2010 State Urban Championship, or who have members appointed as officials. Brigade Secretaries are asked to bring this notice to the attention of:-

- Brigade members appointed as Officials
- Brigade coach
- Brigade Officer or Member in Charge.

#### **APPOINTMENT OF JUDGES AND OFFICIALS**

List of Judges and Officials appointed for the Senior Urban State Championship is attached.

To effectively cater for several areas of function, it was necessary to vary the preferred choice of some officials offering their service. To those members, the Association trusts that their appointed position will be accepted in good faith.

The Association has been very pleased at the response from judges and officials, and wishes to thank all members for their interest and nomination.

I would ask if the brigade members who are nominated should, through circumstances, not be able to attend or be present during the whole of the Championship, advise me so that alternative arrangements can be made to ensure full coverage in all events.

If any person appointed as an official will be competing in an event, please give early notice to the Chairman of the respective Officials Panel to ensure they are not appointed to the event in which they are competing.

#### **OFFICIALS**

Officials are requested to report to the Chairman of Judges' office at the Competition Track between 1600 and 1730 hours on the Friday afternoon. Alternatively, Officials can report to the Chairman of Judges' office on the Saturday morning following the Official Opening and before the start of the Ladder Race. It is requested that Officials attempt to report to the Chairman of Judges at either of the above times in order that their presence can be recorded for the information of the Chairmen of the Officials Panels.

The Senior Championship will commence:	Saturday	- 0900 hours
	Sunday	- 0815 hours
	Monday	- 0815 hours

Roll call on Sunday and Monday will commence at 0800 hours. Events to continue through the lunch period on each day. The first event on Saturday will be the Discipline Contest following the Official Opening to be held at the Eleventh Street Recreation Reserve. This will be followed by the Ladder Race at the competition track.

**Officials are requested to be in attendance at the plug line at the conclusion of the event prior to their appointed event, so that they can be issued with a tabbard, have their name ticked off and any information may be communicated to them.**

Officials are requested to regularly check the appointment board at the Chairman of Judges Office to enable events to get underway on schedule. At all times when officiating, approved CFA dress or summer uniform to be worn. The service style NATO jumper is approved attire in lieu of the blue dress uniform coat. All officials will wear an appropriate tabbard while officiating.

### **COMPETING BRIGADES**

Seventy Three (73) teams have entered, with 20 in 'A' Section, 23 in 'B' Section and 30 in 'C' Section, including Bassendean, Harvey, South Kalgoorlie and South Hedland brigades from Western Australia, and combined teams Deniliquin/Hay and the Angels from New South Wales. Three entries are from approved combined brigades: 'A' Section – Drouin/ Bunyip, Trafalgar/Moe; 'B' Section – Bairnsdale/Lakes Entrance.

### **DISCIPLINE AND BEHAVIOUR**

It is important with each State Championship, that we all take care our past record and image is safeguarded and that the established standards of discipline and behaviour on and off the track is observed.

Those members appointed as Officer in Charge of their Brigade contingent are responsible for the discipline and behaviour of their members at all times.

The consumption of alcohol is not permitted on or in the vicinity of the Competition Tracks, Discipline parade ground or the assembly area for the Torchlight Procession.

**Note: Initiation practices are not acceptable and will not be tolerated at the State Championship. Brigades taking part in such activities risk disqualification from the Championship or future Championships.**

### **DRESS**

Brigade members must be properly attired at all times. CFA issued dress uniform and competition uniform are acceptable but not a combination of both. Competition jumper or singlet or shirt to be worn at all times.

### **PROGRAM OF EVENTS**

The order of events are attached. Roll Call for Brigades on Saturday is at 0830 hours for commencement of the Echelon Movement and Opening Ceremony at 0900 hours; Roll call on Sunday and Monday will commence at 0800 hours – with events on both tracks to commence at 0815 hours.

Any Brigade not able to participate in any event is required to complete a scratching form prior to the event being held. The minimum entries to conduct two heats is twenty teams.

### **ECHELON MOVEMENT & OPENING CEREMONY**

All Brigades are requested to be in attendance at the Eleventh Street Recreation Reserve by 0830 hours for Roll Call. The Echelon Movement and Opening Ceremony will commence at 0900 hours prior to the Discipline Contest.

### **DISCIPLINE CONTEST**

The Discipline Contest will also be conducted at the Eleventh Street Recreation Reserve.

Practice is not permitted on the Discipline Oval on Saturday 6<sup>th</sup> March; a practice area is available on the roll on area at the competition track.

Drill movements and judging will be as set down in the Squad Drill Manual, circulated to each brigade on 22<sup>nd</sup> January 1985 and as amended by a CFA Circular distributed in December 1995.

To assist orderliness and discipline of members on the parade ground, Discipline Squad Commanders should observe that when called, only the squad and one assistant who shall be in uniform, should enter the parade ground. When the brigade section is called ready for inspection, only those members with officials will be permitted on the parade ground arena.

**ROLL CALL & JUDGING OF BRIGADES:**

Roll call of all brigades, including those brigades in the Echelon Movement, will begin at 0830 hours sharp.

**JUDGING:** All Brigades, including those marching in the Echelon Movement, will be inspected prior to stepping off in the Discipline Contest.

**Line Up for Roll Call and the Opening Ceremony – 0830 hours:**

Echelon Brigades - at their designated Echelon Movement marker.

All other brigades in file behind the Echelon Movement brigades with A Section brigades to the right hand side when viewed from the Dais, followed by B Section and C Section brigades. Brigades to line up in program order within their Sections, as per the attached sheet.

A MAXIMUM OF TWO (2) PERMANENT PERSONNEL IN UNIFORM WILL BE PERMITTED TO MARCH WITH THE BRIGADE THEY ARE OFFICIALLY ALLOCATED TO, SUBJECT TO THE MEMBER/S NOT BEING A VOLUNTEER MEMBER OF A BRIGADE ENTERED AT THIS CHAMPIONSHIP UNLESS APPROVAL IN WRITING HAS BEEN OBTAINED.

**TORCHLIGHT PROCESSION**

The Procession will take place on the Saturday commencing at 2030 hours and will march in groups as shown on the attachment. Brigades to assemble in their groups with the required members to march, not later than 2000 hours. Brigades to refer to CFA Circular which will be circulated prior to the Championships for details of assembly points.

A MAXIMUM OF THREE (3) PERMANENT PERSONNEL IN UNIFORM WILL BE PERMITTED TO MARCH WITH THE BRIGADE THEY ARE OFFICIALLY ALLOCATED TO, SUBJECT TO THE MEMBER/S NOT BEING A VOLUNTEER MEMBER OF A BRIGADE ENTERED AT THIS CHAMPIONSHIP UNLESS APPROVAL IN WRITING HAS BEEN OBTAINED.

Borrowing of Competitors to march in Torchlight Procession: Where a brigade does not have sufficient numbers of its own competitors to march the minimum number required in the Torchlight Procession, up to three competitors may be borrowed from another brigade to enable the team to march the minimum number. The approval of the brigade from which the members are to be borrowed must be obtained.

**NAME PLATES:**

Brigades to collect their Name Plates from the Mildura Fire Station by 1945 hours on the Saturday. Name Plates to be handed in at the end of the procession to an Authority Officer. Kerosene will also be available at the Fire Station. A decanting drum will be available at the conclusion of the Procession to decant torches.

**GENERAL INFORMATION**

**ADMISSION TO GROUND:**

Public admission will be free for all attending. Programs will be available for purchase at the gates and within the ground.

**BREAKFASTS:** The Mildura brigade will provide breakfast at the track each day. Food stalls including light refreshments, take away foods, soft drinks and ice cream will be available throughout the day.

**EX-URBAN FIREFIGHTERS VICTORIA:** The Annual Meeting and Dinner of Ex-Urban Firefighters Victoria will be held at the Mildura Workingmans Club on Sunday evening 7<sup>th</sup> March. Dinner at 6.00pm in the Bistro at members own cost; the AGM will follow at 8.00pm in a separate area within the Club. The Committee will be pleased to welcome all members, intending new members and their partners. Please contact Secretary Doug Cole on telephone 9791 3603 or P O Box 2046 Dandenong East Vic 3175 to confirm attendance prior to 1<sup>st</sup> February 2010, or for further information.

**DRAW OF EVENTS:**

The draw for each event will be available from the VFBV Web page two weeks prior to the Championship.

**CLOSING CEREMONY:**

Immediately after the completion of the final event, teams and competitors to assemble on the Main Track for the Announcement of Section Winners, Presentation of Aggregate Trophies and the Closing Ceremony. Assembly to be arranged by Association members.

It is requested that Brigade Members assemble on track and on being called forward to receive a trophy be in Brigade uniform, competition dress or in the brigade's official tracksuit. After the presentation of trophies the Closing Ceremony will be completed by a reading of the Epilogue.

The Association's guidelines now state that the bar will remain closed from the commencement of the Final of the Champion Four event to the conclusion of the Closing Ceremony.

**PARKING:**

Car parking is available in the vicinity of the Recreation Reserve. When parking on adjacent roads, members to observe local and normal road traffic conditions.

**INFORMATION FOR BRIGADE COACHES**

**RULES:**

The conduct of all events shall be in accord with the Urban Competition Conditions and Rules as prescribed in the 2008 Rule Book.

**SCRATCHING FROM EVENTS:**

Brigades who intend to scratch from any of the events at the Championships are asked to report to the Association office at Mildura. Official scratching forms to be completed by the Coach or Senior brigade representative. Early advice and completion of forms will greatly assist the Marshalling Officers.

**BORROWED COMPETITORS**

The Association has re-introduced a form to be completed by brigades wishing to borrow a competitor from another competing brigade on the days of the Championship. The completed form must be lodged with the Association office prior to competing. A "Borrowed Competitor form" is attached.

**STORAGE OF REELS:**

To be parked on Sarah Oval adjoining the competition track. Buses and cars to be removed from oval.

**INCAPACITATED COMPETITOR:**

Coaches are advised that an incapacitated competitor should not be permitted to compete if their incapacity could impede them from competing safely.

**NO BALL GAMES:**

Competitors are reminded that no ball games are allowed on the roll on oval or in the vicinity of reels, competition tracks and the general public. Ball games are definitely prohibited in the interest of safety in the areas specified.

**LADDER RACE EVENT:**

Will commence on the main competition track following the conclusion of the Discipline Contest.

### **TESTING HYDRANTS, REELS AND EQUIPMENT:**

Equipment shall be tested, weighed and suitably marked or officially recorded. Times for testing are:-

Friday	- 1500 to 1700 hours
Saturday	- 0700 to 0815 hours
Sunday	- 0730 to 0800 hours
Monday	- 0730 to 0800 hours

At the following locations subject to alteration by the Governing Body:

Main Competition Track – Hydrants; Back Caps (both).

Testing Station (roll on area) – Branches; Dummies; Ladder Harness; Reels; 'Y' piece.

Couplings on all hoses should be presented for inspection on the Friday afternoon or Saturday morning at the Testing Station to overcome any last minute repairs or recoupling at the roll-on area.

All the above equipment may be subject to random checks during the Championships.

If it is necessary for the lugs on the hydrant to be re-grooved, the Association will have the necessary equipment available at the Championships.

### **SAFETY CO-ORDINATOR:**

In continuing the emphasis on Occupational Health and Safety at competitions and Championships, a Safety Co-ordinator will be appointed to oversee all safety related aspects both on the competition track and within the grounds. If brigades have any safety concerns, they should be reported to the Association office.

### **TESTING OF WATER:**

The water will be tested prior to 0815 hours on each day of the Championships. The times will be announced following each water test.

### **ROLL CALL:**

For competition events, roll call will be taken 15 minutes prior to the commencement of each event, the events commencing on each day:-

Saturday	-	Ladder Race at conclusion of Discipline Contest
Sunday	-	at 0815 hours Hydrant Race
Monday	-	at 0815 hours 'A' Section Pumper and Ladder and 'B' Section 'Y' Coupling - Four Competitors.

### **PROTESTS:**

Official Protest Forms are available from the Association Office and only these forms will be recognised.

To assist with conduct of event being conducted, Brigades intending to lodge a protest must also inform the officiating Track Master of their intent WITHIN FIVE MINUTES of the completion of their run.

In future where a Protest is upheld and the brigade was competing in pairs, unless exceptional circumstances exist, the announced winner of the heat will not run in the next round or final (unless included in the fastest losing teams).

The decision of the Protest Committee shall be final, and if the protest is deemed by the aforesaid Committee to be frivolous, the Brigade shall forfeit the deposit.

### **HOSE REPAIR SECTION:**

Officers of the Fire Safety Section will provide a repair service for competition hose, adjacent to the "rolling on" area.

### **EQUIPMENT:**

Approved hose: a list of competition hose approved for use in hose reel events is attached.

## **TROPHIES:**

Presentation of Trophies to all placegetters will be on the main track as follows:

Vouchers for all other individual trophies won at the Championship will be given to the placegetters at the time of the presentation of trophies for each event, with the individual trophies to be collected via the voucher from an area set aside for this purpose.

Station trophies for First, Second and Third placed brigades in “wet” events will be presented at the conclusion of the event unless the event is the final event of the day. Station Trophies for the final event of each day (except for the Champion Fours event) will be presented at 0800 hours prior to the start of the next days events.

## **MEMBERS ELIGIBLE TO COMPETE:**

Members of Urban Fire Brigades participating at Mildura to be eligible to compete must have been enrolled by the Brigade and registered with the Country Fire Authority as a member of the Brigade they are participating with prior to competing.

Fire Brigades from Victoria and Interstate approved by the Association to participate, are required to have their members taking part to be enrolled members prior to competing.

Under mutually agreed conditions with the Chief Officer, permanent CFA personnel are permitted to participate in Urban competition with the Brigade they are appointed to, subject to they not being a volunteer member of a brigade which is an entered participating brigade at these Championships unless the approval of that brigade has been obtained.

## **SHELTER - ROLL ON AREA:**

With the expectation that Brigades may wish to have a temporary shelter erected at their reel site, arrangements have been made with the Local Committee for brigades to erect a small shelter at or near their reel/trailer site.

The guidelines for Brigades wishing to have a small shelter for their members are:

- preferably to be of awning type (tents may be approved on a year to year basis depending upon the requirements of the Reserve Management);
- to not exceed: width - 2 metres; length - 4 metres;
- to be sited inside oval fence, with reel/trailer in front of;
- to be plastic pegs with support ropes; for safety tent pegs need to be taped over or covered.

**BRIGADES ARE REQUESTED NOT TO USE LONG PEGS, AS A PLASTIC WATERING SYSTEM IS INSTALLED BENEATH THE OVAL.**
