## State President's Report



It has been a big year, and volunteers have confronted some issues that called for almost unprecedented actions while others called for steady, day to day representation.

All of them have pointed to VFBV's good standing

and the valuable work of our elected representatives, Brigades and individual volunteers in the interests of the communities we serve. They have also led to progress on issues of considerable importance to volunteers.

We had the support of volunteers everywhere as they collected signatures on our Firefighters' Cancer Petition, enabling us to have two State MPs, one from Labor, one from the Coalition, table over 16,000 signatures in Parliament, calling for fairer and simpler cancer compensation for CFA volunteers and our career colleagues.

With progress on the issue stalled, VFBV had also supported a locally organised volunteers' rally at Scoresby that attracted hundreds of volunteers and the attention of the national media to the firefighters' cancer issue.

A few months later, a political announcement, made without consultation just a week before the State Election, led to the VFBV Board's Open Letter to the People of Victoria, a significant action that was not taken lightly by the Board.

Through all of this, VFBV, our network of District officials and BMT members at Brigades continued the routine

work of raising the issue of fleet funding – the need for ongoing base funding and a rolling, five year plan of vehicle replacement to bring CFA's front line fleet up to date.

At year's end, neither the cancer issue nor fleet funding is resolved, but we have made some progress; two successive governments have committed extra one-off funding for scores of extra CFA fire trucks, and both Labor and the Coalition have made public commitments to presumptive cancer legislation for firefighters. With the cancer issue still unresolved, our work centres on ensuring that the legislation goes ahead, and that it treats volunteers and our career colleagues equally. To that end, many Brigades are in discussion with their local Members of Parliament and VFBV representatives are working to keep the issue fresh in the mind of State Government.

The hard work of VFBV delegates, individual volunteers and Brigades continues to pay off. Our volunteer representatives are always working behind the scenes on Joint Committees, Working Parties and in regular contact with the Minister, the Emergency Management Commissioner, the CFA CEO, Chief Officer and Board, and others. Every two months volunteers meet with the Minister as part of the Volunteer Consultative Forum – an initiative first designed and proposed by VFBV.

Working for similar recognition and involvement at the national level, we have this year taken part in the signing of a Memorandum of Understanding between the volunteer body CAVFA and the emergency industry body AFAC which gives us a greater voice on issues that impact volunteers at the national level.

Volunteers at the front line have been a part of all of this, and it is great to see both VFBV affiliations and Welfare

Fund membership rising to new record levels this year. These are not only strong signs of support for VFBV's work as the voice of the volunteers, they are also ways in which Brigades can be more involved and benefit their members. The Welfare Fund in particular provides much needed benefit, distributing small grants to assist volunteers who are experiencing significant financial hardship. This year the Fund was able to assist 38 fellow members with grants totalling just over \$101,000.

This year the Board noted the retirement of Board Member Bruce Vine AFSM, who has been an important leader within VFBV and a very active contributor at the State level since 2001. Bruce has long been a familiar face at events across the state, and an active worker for volunteers everywhere.

And with sadness we heard of the death of serving State Councillor, ex Captain Bill Polwarth. A noted contributor to his own community, Bill was 45 years a CFA volunteer and seven years a VFBV State Councillor. Bill's home town afforded him a very public farewell, and just like a Brigade that loses a member, the VFBV Board and State Council were affected by the news of his passing.

I would like to express my personal thanks to all who have contributed through the year; my fellow VFBV Board members, State Councillors and District Council members for their continued input into issues that affect volunteers, Chief Executive Officer Andrew Ford and his dedicated staff, both at Burwood East and those who work in the field, and the individual volunteers who have taken up issues and had their say at the local level, adding to the voice of the volunteers that is VFBV.

Looking back on a year's work it is important to lift our heads from the day to day issues, and the events that may have absorbed a lot of our effort, and consider the real measures of our success as an association.

Did we really engage and involve our members, are

the decision makers taking us into consideration and are the vast bulk of volunteers happy that we are doing a good job for them, and for the communities they protect?

In terms of simple measures, we can point to another increase in affiliations; where five years ago 60% of Brigades were making the choice to affiliate, the figure is now 93%.

Another measure would be the record participation in the annual VFBV Volunteer Welfare and Efficiency Survey; more than double the good response we had to the first survey three years ago. And while the survey has engaged more volunteers, it has also given their opinions greater impact with decision makers. Where VFBV had to work hard to bring the valuable data from the first survey to the attention of the sector's decision makers, the 2014/15 survey report has gone to all Members of Parliament, we have made a presentation to the Minister, the Emergency Management Commissioner has applauded the survey as an excellent tool for all who work to understand and support the needs of volunteers, and the CFA Chair and senior managers have placed considerable importance on making use of the results as a guide to CFA's own decision making.

That attention from the decision makers at the highest levels showed up in very practical ways; the EM Commissioner was careful to assure volunteers that the new EM Volunteers

Statement would strengthen and complement the CFA Volunteer Charter, not replace or weaken it, and the Minister for Emergency Services responded quickly to our questions about the Fire Services Review with her assurance that it would not involve a merger or boundary changes affecting CFA and MFB, and to our questions about union pressure to change the CFA Board with assurances that the skills based Board would remain.

That level of attention from the State's top decision makers would have been a lot harder to achieve five years ago. That is partly about our accumulated achievements such as the writing of the CFA Volunteer Charter into the CFA Act, but it is just as much about volunteers speaking up for themselves.

Our work has involved long term representation and we have put a lot of effort into working with both sides of politics to make sure they fully understand the major issues of importance to volunteers. There have still been some major policy decisions that disregarded our conversations and some issues remain unresolved, so the work of representation goes on.

While we felt we had good progress with the issue of presumptive legislation – the Firefighters' Cancer Law – the commitments made to us have not yet turned into legislation and there are real questions about how the issue will progress from here.

The closure of Fiskville raised issues from the wellbeing of individual volunteers to the future of CFA's ability to train and maintain the skills of its vast volunteer resource. We have worked with individual volunteers, government agencies and a Parliamentary Inquiry, while the issue itself took a number of unpredictable turns.

Into the new financial year, we look to strengthening our connections with individual Brigades through their Brigade

Delegates and improving our communication processes. It is at that level that we can best identify the practical issues and solutions that matter most to Brigades. Over the past twelve months, that work has included beginning the discussion on the next generation of pagers, volunteer testing of new digital scanners and the negotiating of a fair subsidy and distribution of the units, better registration and insurance arrangements for Brigade Owned Vehicles, a phased system of BA Competency, a CFA commitment to the wider availability of first aid training, and volunteer testing of new cold climate jackets.

I also encourage all volunteers to think about how VFBV's draft new vision points to our future; "Strong Volunteerism, Embraced to Build Community Resilience for a Safer Victoria".

Our robust presence with government and the EM sector, and our progress on issues, rests on volunteer involvement at every level, and this year we have had some great motivation and organisation on issues coming from District level. The local efforts of volunteer representatives add to the quality of VFBV's decision making and to the weight that our words carry in the halls of power.

There is no denying that this has been a very difficult year for CFA and at times for volunteers; certainly not everything has been going our way; but we are making our voices heard and taking part whenever issues affect volunteers, Brigades or the communities we protect.

I would like to thank VFBV's hard working staff, our Delegates at every level, our members for their involvement, our VFBV Board Members for their guidance and commitment, and every volunteer who took action, had their say or spoke up this year.

## A Snapshot of 2014-15

There was talk of an early start to the summer season this year, with significant calls on CFA's volunteer based surge capacity, the ability to field large numbers of trained, experienced firefighters anywhere in the state at short notice, beginning as early as September.

And while the season was not as demanding as in some recent years, there were still significant fires in December in the Creighton's Creek, Eppalock and Tooboorac areas, more in January around Wodonga West, Longwood, Moyston and Lake Rowan, and early in February in the Yaapeet/Riddell's Creek/Kilmore area.

CFA despatched crews to assist South Australia's CFS in January, and 150 Victorian personnel went to Western Australia during major fires in February.

The closure of CFA's Fiskville Training College presented challenges in the need to support members affected by reported exposure to hazards at the site, and the loss of a significant part of CFA's practical training capability for local Brigades and live-in training for specialist and command roles.

The resulting Fiskville Inquiry went on to be one of a number of major forums that called upon VFBV to represent volunteers, along with the reopened Hazelwood Mine Fire Inquiry and the Victorian Parliament's inquiry into the conduct of the 2014 State Election, all of which were still under way at year's end.

VFBV's work of recent years continued to benefit volunteers in the form of the continued Volunteer Emergency Services Equipment Program (VESEP) that provides two for one funding for Brigades, the continued success of the VFBV Volunteer Leadership Program that

has now produced over 200 graduates with Certificate IV in frontline leadership, and the successful VFBV Volunteer Forums conducted around the state.

The VFBV Volunteer Welfare and Efficiency Survey's third report on volunteer opinion went further than ever before, with a record number of volunteer participants, the endorsement of the Emergency Management Commissioner and the final report being presented direct to the Minister for Emergency Services.

VFBV's stamina in campaigning for presumptive legislation providing fairer and simpler cancer compensation arrangements for Victorian firefighters produced commitments to legislation from both Labor and the Coalition ahead of the November 2014 State Election. Individual volunteers everywhere did their bit, collecting one of the largest petitions to be tabled in the current Parliament and raising the issue with their local MPs.

Our work on achieving ongoing, core funding sufficient to bring CFA's front line fleet of emergency vehicles under the accepted 20 year age limit continues, but has already influenced two successive governments to allocate additional funding equivalent to VFBV's estimate of the \$30 million required each year to do the job. Again, Brigades and individual volunteers have played their part in highlighting the issue with Members of Parliament.

At a practical level greatly appreciated by many Brigades, VFBV's work in ensuring Brigades have access to subsidised digital scanners to replace the analogue machines made redundant by CFA's move to digital radio was close to completion at the end of the year, while the push to ensure the next generation of pagers is volunteer-tested and suited to volunteers' needs continues.

There were successes for VFBV initiated improvements, with the CFA Chief Officer's approval of phased BA qualifications, the introduction of female PPC made available for all female volunteers on request, and the resolution of long standing problems with the insurance and registration of Brigade Owned Vehicles, which came with VESEP funding sufficient to cover BOV registration for two years, a significant saving to the Brigades.

Going into the new year, VFBV is about to open its fourth volunteer survey, there are continuing campaigns running on presumptive legislation and fleet funding, and we are representing volunteers before a number of parliamentary and government inquiries. We go equipped with record numbers of Brigades showing their support through affiliation, a good working relationship established with the new State Government and growing numbers of volunteers involving themselves in VFBV's work.

*In other words, it is business as usual.*

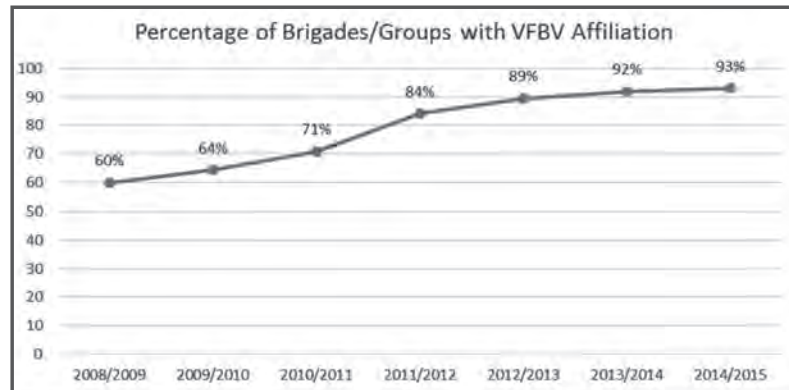
## VFBV membership at an all-time high

A record 93% of Brigades and Groups chose to affiliate with VFBV in 2014-15.

The lowest level of affiliation in any District was close to 80%, far above the statewide average of just a few years ago, and Districts 13, 22 and 23 achieved 100% Brigade affiliation.

Most District Councils achieved affiliation rates in the 90s for their Districts' Brigades, and 10 Districts were at 95% affiliation or higher.

The rise is being attributed to the hard work and good local representation of District Councils and Brigade Delegates, assertive statewide campaigning on major and sometimes controversial issues, and the benefits of additional involvement in VFBV forums and decisions, and eligibility for the VFBV Volunteer Welfare Fund, that go with affiliation.



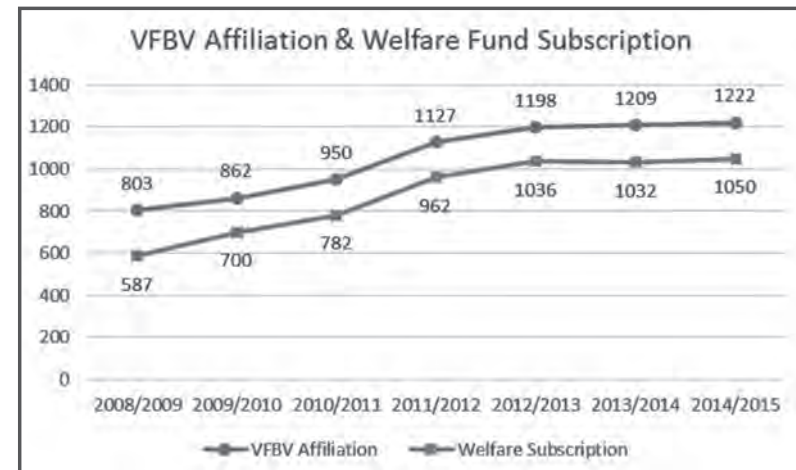
## Volunteer Welfare Fund – most Brigades are members

Brigade membership of the VFBV Welfare Fund has risen to a new high, with 1,050 Brigades subscribing this year, compared with fewer than 600 six years ago.

In 2014-15 the Welfare Fund distributed \$101,162 to 38 volunteers experiencing financial hardship.

Over more than a century, the Fund has helped close to 1,100 volunteers. It offers small grants to CFA volunteers, long serving former volunteers and their families, who are experiencing significant financial hardship. Typical cases involve prolonged illness, bereavement, loss of earnings, or the accommodation and travel costs associated with supporting a relative in hospital.

The Welfare Fund is run under Australian Tax Office rules, independently audited, uses only State Government approved investments, and the welfare grant and investment decisions are made by a committee of long serving CFA volunteers. To subscribe to the Welfare Fund, Brigades must be affiliated with VFBV, which covers the operating costs, so any money the Fund receives is used entirely to help volunteers in need.





## Protecting & supporting volunteers

### Brigade Owned Vehicles

Hard work by VFBV and our representatives on the VFBV/CFA Joint Equipment and Infrastructure Committee produced good news for Brigades with Brigaded Owned Vehicles (BOVs) this year.

In September 2014, an agreed solution with CFA, the State Revenue Office and VicRoads allowed CFA to centrally register BOVs while the Brigades retained ownership. That resolved the technical difficulties that had left some vehicles unregistered and some Captains and Secretaries dealing with traffic fines and demerit point losses on their personal licences. It also allowed Brigades with personalised number plates on their vehicles to keep them.

And in June 2015, the Joint Committee had more good news on BOV insurance. CFA had approved VFBV's call for a budget allocation to ensure Brigades received the full replacement cost of vehicles that had been written off – an important achievement since most emergency vehicles can't just be bought off the shelf, and provides assurance for Brigades with vehicles deployed elsewhere in the state.

### Scanners/Listening Sets

After an initial delay, this year brought us close to a successful resolution of the issue of thousands of analogue scanners and listening sets becoming redundant as CFA's despatch system goes digital.

The issue was first revealed by VFBV's 2010 Scanner and Listening Set Stocktake, which revealed thousands of analogue machines in use by Brigades and volunteers.

VFBV worked hard to ensure volunteers took part in trialling new digital machines, and CFA accepted our call for an equitable subsidy scheme to ensure as many affordable digital scanners go to each District as possible.

There was a delay when Emergency Management Victoria identified upgraded Phase 2 technology to be used in coming years and with CFA still using Phase 1, the Phase 2 scanners had to be tested overseas.

The year ended with CFA expected to announce the successful tender and details of the subsidy scheme soon.

### VESEP Grants

There were VESEP grants for 179 Brigades and Groups from the \$12.23 million program this year, and a new round of funding announced for the coming year.

The grants helped fund 48 vehicles and 131 building, amenities and equipment projects, on a \$2 for \$1 basis, topping up locally raised funds.

VFBV worked with the State Government on the design of VESEP, keeping paperwork to a minimum and letting Brigades choose gear that suits their local needs and fundraising capabilities.

In April 2015, the State Government announced another round of VESEP funding totalling \$12.54 million. Each year VFBV provides an application help pack and case studies from successful VESEP applications at [www.vfbv.com.au](http://www.vfbv.com.au) to support Brigades with their applications.

### Phased BA Competency

A proposal from a Brigade, supported by their VFBV District Council and peers, became a reality this year, when the Chief Officer approved a phased system of Breathing Apparatus (BA) competency.

With development through the VFBV CFA Joint Training Committee, the new competency includes Level One BA for external situations such as car fires, and Level Two for internal structural attack, and search and rescue.

It supports the existing competency by giving members more time to build proficiency in external situations under supervision, before progressing to more advanced training that leads to the higher qualification.

### Union campaign against CFA Board

Volunteers were concerned during the Fiskville Inquiry hearings to learn of a union campaign to replace two of the VFBV-nominated candidates on the CFA Board with union representatives.

Under the CFA Act, the authority has a skills-based Board to ensure it has the skills to run the organisation, including strong volunteer expertise, knowledge and an understanding of CFA volunteerism. It is not a representative Board, and volunteer nominees are required to observe the same independence and confidentiality standards as all others. To guarantee that familiarity, knowledge and understanding of CFA volunteerism, four members of the CFA Board are appointed by the Minister from a list nominated by VFBV.

VFBV approached Emergency Services Minister Jane Garrett for confirmation that there is no plan to change the CFA Board; she indicated that our members can take comfort from her clear statements to the media that the Board membership was there to provide "a diversity of views and good governance..." she said the Government wants to give union members respect and listen to their concerns, but "my view is that doesn't include four positions on the Board of MFB or CFA."

### CFA Credit Cards

With the State Government's cancellation of CFA corporate credit cards early in the year, VFBV began work behind the scenes to ensure the Government is aware of the need for the sensible reintroduction of sufficient cards to allow operational staff to properly support volunteers in the field.

The cancellation caused considerable concern to volunteers over the effects on support to volunteers, with the prospect that urgent items might have to be paid for by volunteers and reclaimed through a bureaucratic system that could take 90 days.

VFBV has worked with the Government and CFA to encourage a sensible reintroduction that ensures volunteers are properly supported by the staff and administrative systems that are there to support them, and at year's end, is hopeful of a resolution soon.

### Cold Climate Jackets

VFBV has worked with CFA through the year to develop a suitable additional jacket as an alternative to provide relief from cold and inclement weather.

With the withdrawal of the black woollen jackets from service, volunteer delegates identified that in colder conditions,

predominantly where members are not issued with Structural PPC, the current Bushfire PPC jacket does not provide sufficient warmth during situations such as road accident rescue, storm events and other non-firefighting applications.

The prototype jackets now being field tested are not intended to replace bushfire PPC, and are not to be used for firefighting, but may be used for other fireground or brigade activity where weather conditions and work load allow.

### Female PPC

VFBV has been advocating for female fit PPC since 2004, saying that female members must be entitled to garments specifically designed for their needs and comfort as a basic entitlement.

Through the year, VFBV received enquiries from members who were unaware that female PPC was available, or who had been told it was only available for new members or if their existing PPC was no longer serviceable.

VFBV requested that CFA again promote the options available, and add female PPC options to all PPC order forms. After hearing VFBV's concerns, the Chief Officer reissued a Memo to all Districts instructing that female fit bushfire PPC is available to all new members, and current members may exchange their existing ensemble.

### Volunteer Support Program

The first phase of CFA's Volunteer Support Program (VSP) closed on 30 June and VFBV worked to ensure volunteers were aware of the program and ready to express opinions as to whether it was having the desired effects at Brigade level.

The program began as a State Government initiative to employ 64 Volunteer Support Officers providing direct support to volunteers, and since its inception, VFBV has pressed for the program to deliver tangible and direct support to volunteers at the local level.

A source of frustration to many Brigades, the final implementation of this critical volunteer support program has been delayed due to Federal Court action initiated by the industrial bodies.

### Sessional Trainers

The 2011 Jones Inquiry supported VFBV's push for the use of sessional training instructors as part of developing an adequate and flexible training instructor and assessment strength to serve the needs of volunteers, and CFA agreed to use sessional instructors whenever volunteer and paid instructors and are not available.

But VFBV's work on the issue was not yet finished; when CFA advertised for Sessional Trainers early in the year, the advertising included an error that would have excluded qualified, experienced volunteers from applying. CFA readvertised in October after VFBV raised the issue, and the renewed advertisements no longer included a requirement that applicants have prior history as paid instructors.

VFBV has been pursuing the issue of Sessional Trainers for several years to help meet the need for training to be volunteer friendly in location, timing and format. However by year's end, VFBV was advised that CFA was having industrial difficulties in progressing the matter any further.

### First Aid

The push for better First Aid arrangements for Brigades has continued, in the wake of reports that Brigades were being sent invoices from CFA reclaiming costs for any members trained in first aid above their Brigade Operational Skills Profile (BOSP) targets.

VFBV provided a 17 page submission to CFA in 2010 calling for an urgent review of First Aid arrangements and after repeated attempts to have the issue resolved, VFBV received assurances that CFA is close to finalising new arrangements that will address the volunteers' concerns.

VFBV called for caps on numbers being trained in First Aid to be removed, and that CFA provide easier ways for members' external first aid qualifications to be recognised. VFBV also called for a multiyear strategy, members only having to do an annual refresher of CPR, and 3 year refreshers of first aid, in line with the First Aid Advisory Council of Australia guidelines. VFBV also urged CFA to investigate online skills maintenance

options, and more locally based training to better support and suit the needs of volunteers.

### Committees, Issues and Representation

VFBV's representatives on Joint VFBV/CFA Committees and working groups, Brigades and individual volunteers have worked to resolve a wide range of issues, including;

**WIRE ROPE BARRIERS:** The VFBV/CFA Joint Community Safety Committee was pleased with the news in May 2015 that the Chief Officer had endorsed a position paper addressing Brigades' concerns. The paper calls on VicRoads to consult on clearance from roads and vegetation, emergency access points and training for Brigades in dismantling the barriers.

**MEMBER REGISTRATION FORMS:** VFBV successfully called on the Chief Officer to withdraw new Member Registration Forms in October, after volunteers found they included an onerous medical checklist that caused delays and required new members to pay a medical professional to assist them. At VFBV's request, CFA has agreed to covering the cost for all new member medicals and a simplified, less onerous medical checklist.

**SERVICE AWARDS:** After discussions with VFBV, CFA agreed to drop the current service award upgrade kits so volunteers reaching service milestones now receive a complete new medal instead of having to sew a new bar onto their existing medal.

**MEDIUM PUMPER TOUR:** This year's consultation tour of the prototype Medium Pumper, travelling from Lakes Entrance to Hamilton, was based on the Medium Tanker roadshow that gave Brigades opportunity for hands on inspection, an idea from VFBV that resulted in the Chief Officer approving a list of volunteer-suggested improvements.

### Presumptive Legislation

VFBV's campaign for legislation to give firefighters fairer and simpler access to cancer compensation started the year with volunteers expressing frustration at Victoria lagging behind other States.

The Federal Parliament and three States had passed legislation, hundreds of CFA volunteers had rallied outside the Minister's office, and having given the Coalition Government's new Firefighters' Assessment Panel (FAP) months to prove itself, VFBV had presented the Minister with a detailed briefing on its failings.

VFBV launched a statewide petition and started a Trust Fund to support a ramped up campaign, and was preparing to support a possible test case in the Supreme Court to set aside the first cancer compensation application rejected under FAP.

VFBV wrote to all MPs and volunteers collected petition signatures, calling for legislation listing the same 12 cancers and years-of-service requirements from the Australian Parliament's legislation, with equal coverage for career and volunteer firefighters.

The Northern Territory introduced presumptive legislation, many Victorian MPs supported the volunteers' petition, and VFBV worked to educate those who did not.

Five weeks before the State Election, Labor and Coalition MPs tabled 16,000 petition signatures received by VFBV in Parliament. Four days later, South Australia gave volunteers equal coverage under its legislation by removing the discriminatory volunteer-only requirement that they prove a certain number of turnouts.

In November, Labor took Government in Victoria having promised to introduce presumptive legislation within 18 months, based on the list of cancers and years-of-service requirements in the Tasmanian legislation.

Having had the then Shadow Minister Wade Noonan's assurance that Labor had not backed down on its commitment to presumptive rights for career and volunteer firefighters alike, VFBV has been very clear that expectations are that the Victorian legislation will apply equally to volunteers and staff.

With VFBV working to ensure the Government does not move to add any discriminatory extra requirement to its legislation, there was good news from Queensland, with a strongly supported Private Member's Bill that treats career and volunteer firefighters equally.

At year's end, the Victorian Minister has confirmed that work on the legislation has begun and there will be opportunities for consultation, and VFBV is urging volunteers to make sure MPs know the legislation must list the same 12 cancers and years-of service-requirements and treat volunteers and their career colleagues equally.

### Fiskville Closure and Inquiry

Concerns over the safety of CFA's Fiskville Training College continued, with the Fiskville Firefighters' Health Study by Monash University adding to the established evidence connecting firefighting and cancer that led to VFBV's campaign for presumptive legislation for all Victorian firefighters.

March brought the discovery of more contamination, the closure of the facility and the launch of a Parliamentary Inquiry.

Having pressed for additional independent testing and information for members since safety concerns first arose, VFBV was well prepared - State Council determined key points for our submission, and VFBV told the Inquiry;

- Any training ground used for hot fire or other training must be safe to use
- Should Fiskville be closed or scaled back, investment to replace its significant state training capability would be required, as the rest of the fire services training network would not cope with the load
- Firefighters who have relied on Fiskville as their local training facility must continue to have locally available access to state of the art training

VFBV stressed that support for members exposed to health hazards at Fiskville must continue; the closure of the facility does not mean their needs are at an end.

VFBV urged the Inquiry to establish a level of confidence amongst firefighters, community, Government and firefighters' representatives, about the facts. There had been a lot of discussion of what is or isn't safe, and what can or can't be fixed. VFBV stressed that volunteers need the Committee to ensure the facts are on the table, that the opinions and assessments of the independent experts are known, and the analysis, decisions and regime going forward are transparent and beyond partiality or self-interest groups.

VFBV called for actions to ensure;

- Independent assurance of safety, based on facts
- Informed decisions on any options for rehabilitating, fixing or reopening Fiskville
- Protection of firefighters, not just during training

## Shaping the Future continued

- Empowerment and support to CFA to address training based on need, not capped artificially based on budget
- Removing the rumour, speculation and uncertainty, and making decisions on independent, expert analysis of the facts

The Inquiry was still under way at year's end.

### Fleet Funding

Volunteers talking to local MPs and VFBV's work with party leaders successfully drew the attention of successive State Governments to the need to bring CFA's front line fleet under the nationally accepted age limit of 20 years.

The Coalition Government announced an extra \$29 million for 78 new CFA vehicles – most of them Medium Tankers designed with VFBV and volunteer input – and the new Labor Government committed \$33 million for 70 new trucks. Both figures are close to VFBV's calculation of the annual funding needed, but the objective of ongoing base funding, backed by a five year rolling plan of vehicle replacement, is still to be achieved.



The campaign began with one in four of CFA's front line vehicles over the 20 year age limit, and VFBV urges volunteers to keep the issue fresh in the minds of local MPs.

### Hazelwood Inquiry

As a major incident in the most intense summer since 2009, the February 2014 Hazelwood Fire raised issues for the community, personnel on the fireground and the future of the emergency services.

VFBV has been involved on behalf of volunteers during the incident, the Parliamentary Inquiry, and the reopened Inquiry under the new Government. Our submission was based on VFBV officials' attendance at the incident as CFA volunteers, feedback from volunteers and a strategic reflection on the issues, including;

- The absolute importance of Victoria's emergency service network maintaining the CFA's volunteer based surge and sustain capacity and capability for large and protracted incidents;
- The importance of adequate protection for all firefighters (paid and volunteer alike);



- Concerns about under-utilisation of volunteers, particularly in senior incident command and specialist appliance roles;
- The need to improve fire prevention across the whole landscape.

The Inquiry was still under way at year's end, and VFBV was working to keep members informed and to support volunteers directly affected by exposure to hazards during the fire.

### VFBV Open Forums

Open Forums continue to be popular, with a good turnout from local Brigades in each of this year's locations.

The forum at Burwood (pictured) included plenty of informal discussion and a panel session with the Emergency Management Commissioner, CFA Chief Officer, CFA CEO, CFA Executive Director of OT&V, and VFBV's President and CEO.



The panel session tackled issues including female PPC, better organisation of strike teams to reduce waiting time, strike teams working in community recovery, improving communication within CFA, better access to information technology for volunteers, uniforms, and concerns with CFA's plans for FEM administration cost recovery from Brigades.

The VFBV Open Forums are an important link with grass roots volunteers and there will be more in the coming year.



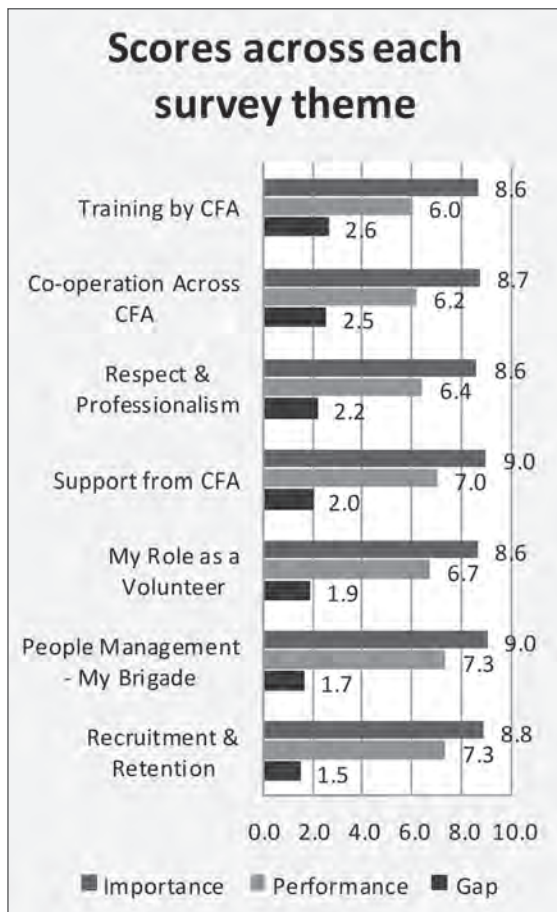
## VFBV Volunteer Welfare & Efficiency Survey

The 2014 Survey achieved a 14% rise participation to more than 1,650 volunteers across the state.

The survey report confirmed strong trends in volunteer opinion that are clear pointers to paths for improvement by CFA. This was our third survey, and results show training is still the biggest issue for volunteers, with the widest gap between its importance and CFA's performance. The overall impression is that the greatest gaps are in training and cooperation, and the smallest gap – the best result – is in the areas of recruitment and retention, how volunteers feel about management of issues and the support they receive at local Brigade level.

The report shows male and female volunteers have different perceptions of how women are treated, there is a visible difference in comments from integrated Brigades about treatment of volunteers, and newer volunteers show a more positive opinion than longer serving members. The survey is fulfilling the hopes VFBV had for it three years ago. It is run by VFBV, informed by growing numbers of volunteers and being put to work as a productive tool by VFBV and CFA.

At year's end, the 2015 survey was just days away, now featuring a VICSES version, hosted by VFBV for the VICSES volunteers' organisation, the Victorian Emergency Services Association (VESA).

## VFBV Leadership Scholarships

Places in this year's sixth VFBV Volunteer Leadership Program course were in high demand, with 92 applicants for 50 positions.

The program is funded by VFBV, with additional funding from the Department of Justice to assist with our multi-agency approach, but with such strong demand we successfully applied to Emergency Management Victoria for top up funding to cover 10 extra participants for 2015, taking the total to 60.

The 70 participants from the fifth course graduated this year with Certificate IV in Frontline Leadership provided under the auspices of Chisholm Institute of TAFE, making more than 200 graduates so far.

The Sixth course is still under way, with participants from CFA, Ambulance Victoria, Australian Volunteer Coast Guard, Life Saving Victoria, VIC SES, and St John Ambulance.

## Shaping the Future continued

### Emergency Medical Response

VFBV welcomed the State Government's extension of Emergency Medical Response (EMR) to all integrated Brigades in February 2015, and urged the Government to continue the expansion to more volunteer Brigades.

Five volunteer Brigades have been providing EMR since 2008 under the pilot, with five Integrated Brigades joining them in 2011.

With EMR, CFA crews trained in advanced first aid and equipped with oxygen and defibrillators are despatched to heart attack calls, frequently arriving and starting resuscitation precious minutes earlier, then handing over to ambulance crews.

EMR significantly increases patient survival rates and is particularly valuable in country areas where ambulance response times can be high. Volunteers at the five Brigades - Berwick, Edithvale, Mornington, South Morang and Whittlesea – say the extra skills are also useful at road accidents and rescue calls

VFBV is encouraging Brigades to consider whether EMR would be beneficial in their area and within their capacity to deliver, and some Brigades are actively in discussion with their communities and MPs.

### CFA Volunteerism Strategy

Following the Victorian Auditor-General's (VAGO) Report into the management of emergency service volunteers in February 2014, work on CFA's Volunteer Strategy began with the direct involvement of VFBV.

We encouraged volunteers to have their say and pressed for CFA to prepare an implementation strategy to inform

and deliver implementation to the District level. The year ended with the plan ready for signoff.

The strategy addresses the lack of an integrated strategic approach to encourage, maintain and strengthen volunteer capacity and capability. Its priority actions for 2015 include; leadership development programs, greater consultation with volunteers and communities, the replacement of Minimum Skills with CFA's new Volunteer Recruit Training Package, better workforce planning and utilisation of volunteers and the establishment of ongoing support officers for volunteers

### Jones Inquiry recommendations

Through the 2013/14 year, VFBV raised concerns with CFA and the Minister regarding poor progress on Jones Inquiry recommendations, and early in the new year CFA acknowledged that their reporting of progress until then had been overly optimistic.

CFA revised its project management structure and its March 2014 progress report, and VFBV pressed for CFA to institute a process that checks that any improvements are actually felt at Brigade level, and has encouraged Brigades to raise the issue through their VFBV delegates if actual progress doesn't match the reporting.

VFBV has been very frustrated by the slow progress on many of the fundamental issues raised in the Jones Inquiry.

### Emergency Management Commissioner

VFBV congratulated Fire Services Commissioner Craig Lapsley as he became Victoria's first Emergency Management Commissioner, working alongside Chief Executive Neil Robertson at the head of Emergency Management Victoria (EMV).

The Commissioner works with VFBV on a wide range of issues and has been available to volunteers frequently through VFBV events including our leadership graduation, AGM and Open Forums.

During the year, the Commissioner worked with VFBV on EMV's draft Emergency Management Volunteer Statement, a positive and reinforcing commitment by the Victorian Government and Emergency Management Sector to consult and engage with volunteers in emergency management on matters that affect them. Commissioner Lapsley has confirmed its intent is to strengthen and complement the existing CFA Volunteer Charter, which will continue as an enduring commitment between Government, CFA and VFBV on behalf of CFA volunteers.

### VFBV's Vision

As the year drew to a close, VFBV drafted a new vision statement to replace the one written in 2007.

The draft "*Strong Volunteerism, Embraced to Build Community Resilience for a Safer Victoria*" is designed to capture the core purpose and ideology of VFBV and clearly demonstrate an outward focus and community benefit motivation for VFBV efforts, to better align VFBV's effort and achieve better respect and recognition of the contribution we seek to make in the EM sector and for Victoria.

The draft will be workshopped at State Council and volunteers are encouraged to discuss their thoughts with their State Councillors.

## 2015 VFBV State Championships

More than 4,000 competitors in 205 teams made for spectacular entertainment at the 2015 VFBV State Championships.

The urban senior championships at Bendigo were dominated by reigning champions Kangaroo Flat in a 65 team competition that featured contingents from Western Australia and New Zealand among the Victorian Brigades.

The rural championships provided close competition at every level between the 46 Brigades represented.

Tatura asserted their claim to the title at the urban junior championships at Horsham, and Willaura won their first ever aggregate and the title of Champion Team at the rural junior championships at St Arnaud.

VFBV sincerely thanks all the participating Brigades, teams, competitors and thousands of spectators for their support and attendance. The host committees at Bendigo, St Arnaud and Horsham made a success of the huge task of running the events, and VFBV would also like to thank the municipal councils in the host towns for their support and many individual volunteers who helped out.

For all of our State Championships events, VFBV wishes to thank CFA and staff for their support, particularly the District Mechanical Staff and Tower Overseers. VFBV also extends its appreciation to major sponsors Ace Radio and Hino for their generous support for volunteer championships, and the many other sponsors and trophy donors. Their support is an appreciable addition to these, the major social and sporting events in the volunteers' year.



## Urban Championships

Kangaroo Flat took the honours again at the 2015 VFBV Urban Championships at Bendigo, winning the title of Champion Brigade for the third time in a row.

The team in green won all events they contested on Day One and 21 year old Jackson Dargaville is now in the record books as the only competitor ever to win the State Ladder Race title five years in a row. He remains unbeaten in this event since he joined the seniors, with more than 30 wins, and was declared Champion Competitor for 2015.

B section aggregate winner Corio put on a great performance with four wins and a number of placings, and Warracknabeal achieved their first state aggregate success by winning the C Section aggregate.

## VFBV Board Appointments

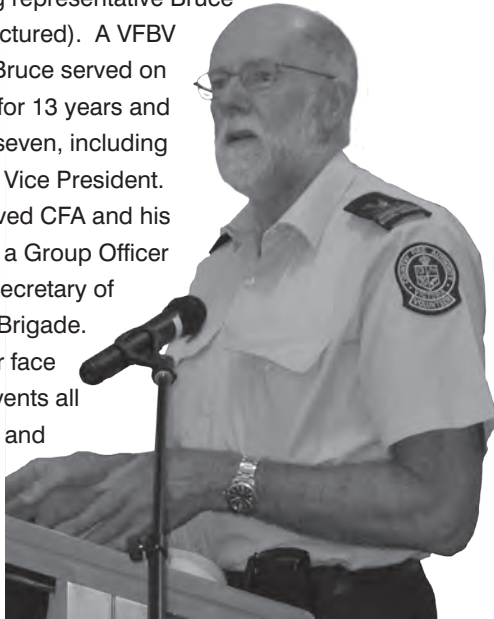

7. To develop awareness, respect and support for CFA volunteers and their fundamental and pivotal role in the CFA as a community based, volunteer based fire and emergency service of the people of Victoria.
8. To take any other action as determined by the Association Board consistent with these purposes.



### Notes to the Financial Statements For the Year Ended 30 June 2015

#### 1 Summary of Significant Accounting Policies

This financial report is a special purpose financial statement prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act 2012 (VIC) and the Australian Charities and Not-for-profits Commission Act 2012. The board has determined that the not-for-profit Association is not a reporting entity.

The financial report has been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The financial report is aggregated to include the numbers of Volunteer Fire Brigades Victoria Inc. and Volunteer Fire Brigades Victoria Welfare Fund.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

##### (a) Income tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997. Volunteer Fire Brigades Victoria Inc and Volunteer Fire Brigades Victoria Welfare Fund are registered with the Australian Charities and Not-for-profits Commission.

##### (b) Plant and equipment

Property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all property, plant and equipment is depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use.

##### (c) Impairment of Assets

At the end of each reporting period, the Association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of income and expenditure and other comprehensive income.

##### (d) Employee benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting year. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

During the year there has been a change in the recognition criteria of long service leave liability. Long service leave is recognized after 5 years of continuous employment with the Association. Long Service leave was previously recognized at the onset of employment.

##### (e) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less.

#### (f) Revenue and other income

The Association recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of Volunteer Fire Brigades Victoria Inc's activities as discussed below.

Interest income is mainly on interest-bearing cash and cash equivalent balances. Interest income is recognised on an accruals basis.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

#### (g) Leases

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term.

Lease payments for operating leases, where substantially all of the risks and benefits remain with the lessor, are charged as expenses on a straight-line basis over the life of the lease term.

#### (h) Goods and services tax (GST)
